The first option period of the contract is to August 30, 2021. Orders issued on or before August 30, 2021 may continue performance through August 30, 2024.

8(a) STARS II allows for directed task orders up to \$4 Million, including options. Orders more than \$4 Million must be competed among the industry partners in your chosen constellation and functional area.

8(a) STARS II offers fixed price, time and materials, labor hour, and blended task order types; providing greater flexibility in procuring IT service solutions to meet your mission requirements.
